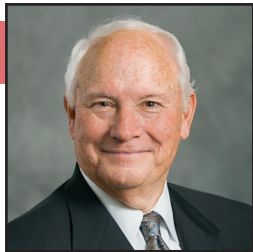

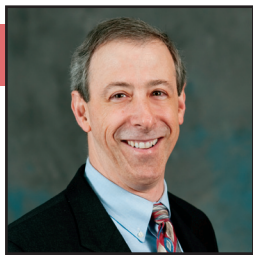

==== City of Dunwoody Referendum =====

“Shall land be acquired and remediated for parks and greenspace by the City of Dunwoody through the issuance of general obligation bonds in the amount of \$33,000,000?”

==== City of Dunwoody Referendum =====

“Shall the park system of the City of Dunwoody be improved by the issuance of general obligation bonds in the amount of \$33,000,000?”

==== City of Dunwoody Redevelopment Referendum =====

“Shall the Act be approved which authorizes the City of Dunwoody to exercise redevelopment powers under the ‘Redevelopment Powers Law’ as it may be amended from time to time?”

==== City of Dunwoody Sunday Alcohol Sales =====

“Shall the governing authority of the City of Dunwoody, Georgia be authorized to permit and regulate package sales by retailers of malt beverages, wine, and distilled spirits on Sundays between the hours of 12:30 PM and 11:30 PM.?”
