

- Road Rage Officers responded to an in-progress road rage incident where the offender became enraged when the victim beeped at her for cutting her (victim) off. The offender followed the victim for several miles. The offender was tailgating, was observed recklessly passing other vehicles and getting out of her car and threatening to fight the victim who remained in her vehicle. A witnessed followed the offender throughout and provided officers with a statement. The offender was arrested.
- Armed Robbery CVS 1610 Mt. Vernon Rd. An unknown suspect, possibly W/M or H/M walked into the CVS white his face covered and wearing a skater's helmet and armed with a medium frame black semi-

auto handgun. The suspect ordered an employee to the manager's office where the manager was. There he grabbed cash and then fled the scene on a mountain bike. The suspect is approx. 5'06", 150 lbs.

Motor Vehicle Accident – Mt. Vernon Rd @ Gramercy Ct - DKPD Motor Officer was involved in an accident as he was assisting in a funeral procession. Vehicle #1 turned directly in the path of the motor officer. The officer's motorcycle struck the driver's side of vehicle #1 and the officer was thrown over the hood and onto the pavement. He sustained minor injuries. PLEASE BE AWARE AND LOOK TWICE!

- Entering Autos- 3 occurred overnight at Two Blocks Apartments, 4000 Dunwoody Park. Entry into all the vehicles was made by punching under the door lock.
- A stolen vehicle out of Atlanta was recovered abandoned in front of DSW Show Warehouse, 4741 Ashford Dunwoody Road.
- Entering Auto/ Attempted vehicle theft 4000 Dunwoody Park (Two Blocks Apartments) occurred 4/27 from 2130 to 0600. Entry was gained by prying under the driver's side door handle. The steering column was broken and the ignition wires were exposed. An 'Alpine' amplifier and an aftermarket stereo were removed from the vehicle.
- Entering Auto 4700 Ashford Dunwoody Rd (J Alexander's) occurred between 2000 and 2157 hours. Entry was attempted by prying under the driver's side door handle, but that apparently failed and the window was broken. A laptop, GPS and a pair of sunglasses were taken
- Motor Vehicle Theft 31 Perimeter Center East 1990 Chevrolet C1500 primer gray was stolen at 1:51 hours by 2 black male suspects who were observed driving up in a maroon 4 door sedan, possibly a Honda. This incident was caught on surveillance camera.
- Entering Auto Embassy Suites 1040 Crown Point Pkwy an unknown suspect(s) entered the victim's vehicle between 4/28 1745 and 4/29 0720 hours and stole his laptop. Entry was made by prying a door lock.
- Burglary 8200 blk Peachford Circle between the hours of 1045 and 1300 an unknown suspect entered the apartment and made off with 1 Chanel bag, 1 Celine bag, 2 Movado watches, 1 Rose Gold watch, and 1 Cartier bracelet. No force was used to gain entry.
- Entering Auto 246 Perimeter Center Pkwy an unknown suspect(s) damaged the door lock and entered the victim's truck. A Smith & Wesson .38 special revolver, along with a black 32g Apple iPad, and a red briefcase containing miscellaneous computer components and personal effects were missing.
- Stolen Bicycle 1850 Cotillion Dr an unknown suspect stole a Trek bicycle which was secured on the first level of the parking deck.

- Motor Vehicle Theft A 2013 Impala was reported stolen at Embassy Suites 1050 Crown Pt Parkwat. The owner advised that he last saw the vehicle at 2100hrs in the parking deck of the hotel. A stolen 2014 Impala from Gwinnett County was located a few spaces over with visible damage under the door handle and a punched ignition.
- Motor Vehicle Theft Axis Apartments, occurred between 04/28 and 04/30. Victim reported his 1999 white Chevrolet GMT-400 C350 truck was stolen from the parking deck.
- Entering Auto- 1201 Hammond Drive, occurred 04/30 between 1330 and 2205 hours. The victim's vehicle was parked behind Nordstrom Rack. Busted window.
- Entering Auto was reported on the access road between 2 Blocks Apartments and Bank of America. Entry was made by prying the rear window. \$700 in cash, a purse and a watch was taken from the vehicle. Occurred between 1200-1230hrs.
- Entering Auto 4560 Olde Perimeter Way an unknown suspect(s) damaged the door handle and gained entry into the victim's vehicle where the suspect gained access to the trunk and stole a laptop.
- Entering Auto 121 Perimeter Center West (Tin Lizzy's) occurred between 2000 and 2349 hours. The rear driver's side window was broken, but nothing was taken. An iPhone was still in plain view on the front seat.

- Aggravated Assault 6890 PIB officers responded to the location to a report of two people that had been stabbed. Initial reports were that two gang members had attacked an 18 year old male and when his mother came to break up the fight a third male stabbed the 18 year old in the upper groin area and cut the mother on the upper arm with a box cutter. Officers located two of the suspects (a juvenile and his father) at their house just inside of Doraville. The suspects gave a very different account of what happened and denied any knowledge of anybody being stabbed. The suspects alleged that the 18 year old victim started a fight with them over the juvenile's girlfriend and was joined by several intoxicated males in attacking them.
- Officer Rodriguez was running laser on I-285 at N Peachtree Rd when a vehicle crossed through the gore area and struck his patrol vehicle. The driver was heavily intoxicated and did not realize that he had just struck a police vehicle. Rodriguez was able to catch up to the vehicle and get him stopped. The driver was arrested for DUI and an assortment of other traffic charges. No injuries were reported by either the driver or Officer Rodriguez
